Making decisions about the subjects and courses to take in Year 11 and 12 is an important step. This guide will help you understand the requirements for the Queensland Certificate of Education (QCE), explore your learning and career goals and develop a draft outline of what your QCE pathway might look like.

## What is this all about?

You will experience a variety of activities to help you explore options regarding post year 12 opportunities as well as opportunities while you are at school. Throughout your Futures Unit you have also had the opportunity to narrow your focus and explore possible career pathways, jobs and what is required.

You are now ready to formalise your SET Plan for your Senior Schooling Studies.

## SET Planning

A SET Plan is a 'Road Map' to assist young people in achieving their learning goals during the Senior Phase of Learning. It assists young people to examine options across education, training and employment sectors and allows them to communicate with personnel at the school who work collaboratively to achieve their goals.

## Preparing for Learning in Years 11 and 12


Senior schooling is an exciting time and an important step in planning for your future. In year 10 teachers and staff at Rochedale State High School will work with yourself and your parents/care givers to develop a plan to assist you:

- Think about your education, training and goals after year 12
- Tailor your learning in Years 11 and 12 to suit your abilities, interests and ambitions
- Map your pathway to achieving a Queensland Certificate of Education (QCE).

Once your plan has been developed, you will be registered with the Queensland Curriculum and Assessment Authority (QCAA) and your learning account will be opened.


### *Two important parts of Senior Schooling*

The Queensland Certificate of Education (QCE) and the ATAR (Australian Tertiary Admission Rank) are different and have a different purpose.



QCE

Certifies learning, showing the individual has achieved a specific standard of education at senior schooling level and may be considered by employers and the general community.



ATAR

Tells us about a student's position (or ranking) compared to all other students in the state. The only intended purpose for the ATAR is to assist with selecting applicants for tertiary study.

## The Queensland Certificate of Education (QCE)

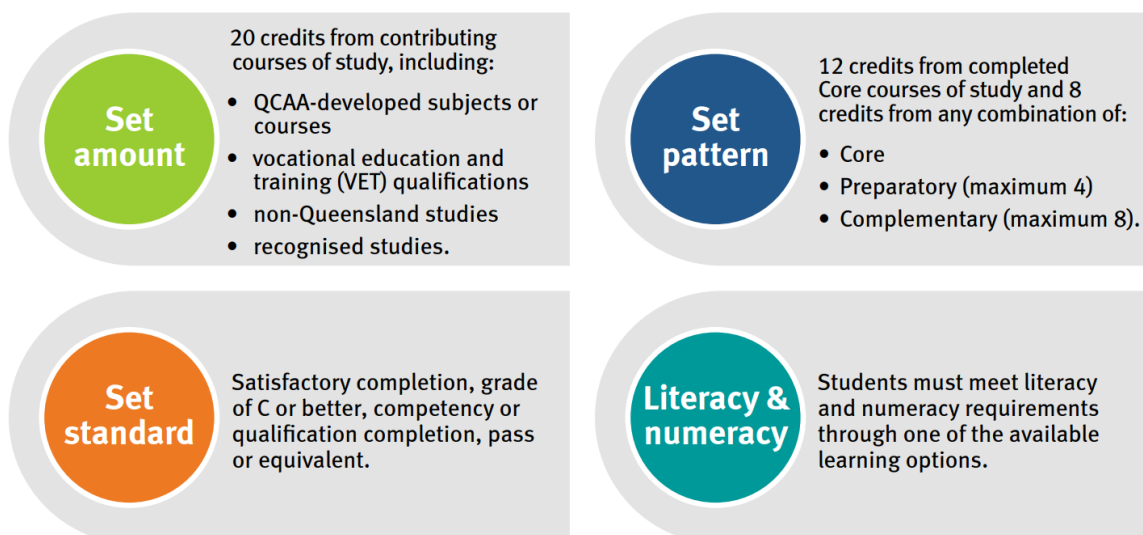
The QCE is Queensland's Senior Schooling qualification. It is internationally recognised and a sign of academic and personal success. The QCE is also flexible and allows you to design a pathway that is right for you – whether you place to:

- Study at university
- Look for skilled work
- Complete Technical and Further Education (TAFE) or other training

### *How does the QCE work?*

To receive a QCE you **MUST** achieve 20 credit points of learning, at the set standard, in a set pattern, while meeting literacy and numeracy requirements.

Typically, students will study 6 subjects/courses across Year 11 and 12. Many students choose to include vocational education and training (VET) courses in their QCE pathway and some may also wish to extend their learning through a university course or other recognised study. In some cases, students may start VET or other courses in Year 10.



### *SET Pattern*

With the set pattern requirement, there are 3 categories of learning – Core, Preparatory and Complementary.

When the set pattern is met, credit will accumulate in your learning account. To meet the set pattern of requirement for a QCE, **at least 12 credits** must be accumulated from completed core courses of study. The remaining **8 credits** can come from any combination of core, preparatory or complementary courses of study.

**CORE:** At least 12 credits MUST come from completed Core courses of study as shown below.

### What can I study?

The QCE lets you choose from a wide range of subjects and courses. There are 3 categories of learning – Core, Preparatory and Complementary – and some subjects and courses are worth more credit than others. The below lists the types of courses, their QCE category, credit values, and Australian Tertiary Admission Rank (ATAR) eligibility.

As evident in the table you are able to study:

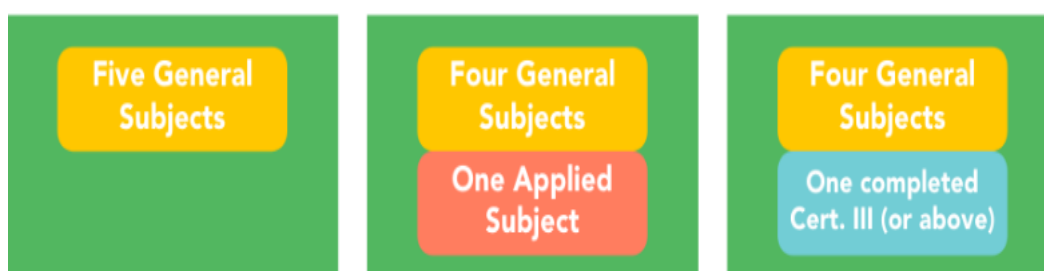
- **General Subjects:** prepare you for tertiary study, further education and training and work. These subjects are designed by QCAA and delivered as 4 units.
- **Applied Subjects:** focus on practical skills and prepare you for work. All of these subjects have 4 units and are designed by QCAA.
- **Vocational Education and Training (VET):** develop skills and prepare you for work through practical training.

## Australian Tertiary Admission Rank (ATAR)


The ATAR is a ranking system that gives you a score to be compared to others and is a measure of your overall school achievement that is used by every state and territory in Australia. The score is on a 2000-point scale from 99.95 (highest) down to 0, and is a percentile rank. The scores decrease in increments of 0.05. If you achieve an ATAR of below 30 it is reported as '30.0 or less'

### ATAR Eligibility

To be eligible for an ATAR, you must achieve a C or higher in an English subject and fit into one of the following boxes:

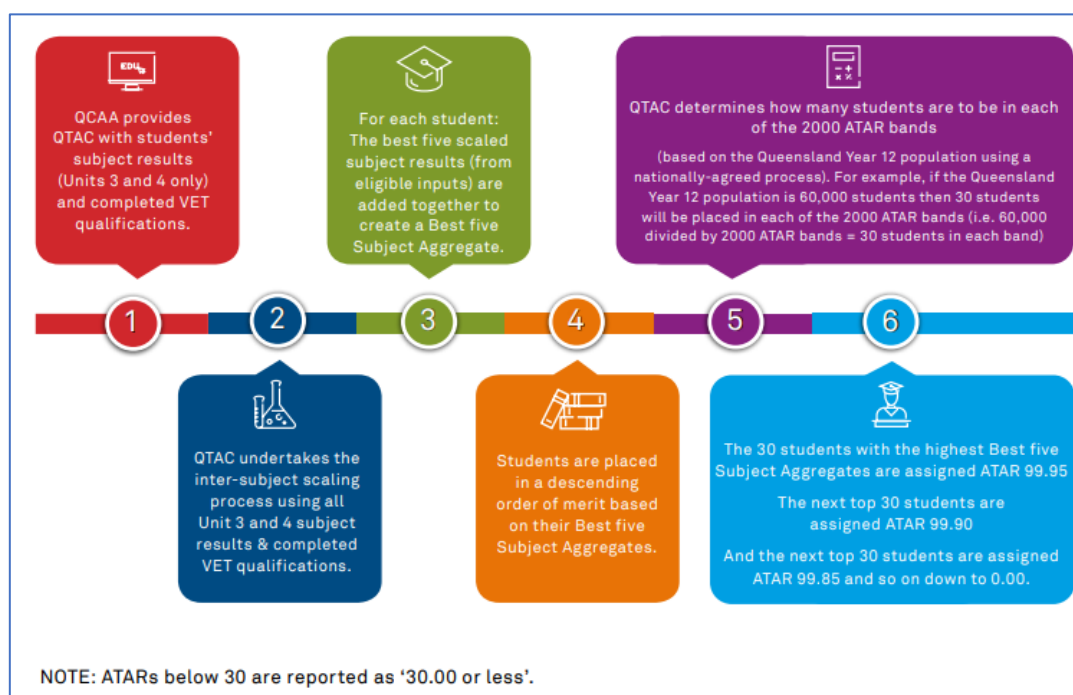

Billie will not be eligible for an ATAR because she has only three General subjects. To qualify for an ATAR a student needs five General subjects or four General subjects plus one Applied subject or one completed VET qualification.

## ATAR Calculations



Your ATAR is calculated based on a combination of the best 5 scaled results from ATAR eligible contributions from the 3 different eligibility criteria below:

- 5 General subjects (at Unit 3 & 4); or
- 4 General subjects (at Unit 3 & 4) plus an Applied subject (at Unit 3 & 4); or
- 4 General subjects (at Units 3 & 4) plus one completed VET qualification at Certificate III level or above

## Inter-subject Scaling

- Scaling is the process where 'raw' subject results are adjusted for a given subject to allow the results for that subject to be fairly compared with the results from any other subject when calculating ATAR.
- To assist you with understanding the scaling process, QTAC has produced a guide "Inter-Subject Scaling: An Introduction" that can be accessed via <https://www.qtac.edu.au/wp-content/uploads/2020/07/Overview-of-Inter-Subject-Scaling-a-white-paper..pdf>
- If scaling did not exist students could maximise their ATAR by studying what they believe are the easiest possible subjects to get the highest possible mark, even though there are other subjects that require more rigour.

## **IMPORTANT**

You should not select subject based on predicted scaling outcomes. You should select subject based on:

- What you are good at?
- What you enjoy/are interested in and can perform well in?
- What the prerequisites for the tertiary course you wish to apply for stipulate?

### *VET and ATAR*

- Each VET qualification level will have a single scaled score that can be included in the ATAR calculation.
- Relevant VET qualification levels for the ATAR are:
  - o Certificate III
  - o Certificate IV
  - o Diploma
- Each level of VET qualification has the same scaled score for ATAR e.g. a completed Certificate III Business has the same scaled score as a completed Certificate III Hospitality.
- Different levels of VET qualifications are expected to scale higher than others i.e. completed VET Diploma will be higher than a completed VET Certificate III.

## Pathways at Rochdale State High School

- Regardless of your pathway, it is expected that all students will work towards attaining a QCE/QCIA at the end of Year 12
- Eligibility criteria for both **RED** and **BLUE** pathways is based upon Year 10 Academic results.
- If you are eligible for a **RED** pathway you will be informed via a letter from the Principal.
- If you do not meet the 92% attendance requirement necessary for either pathway you will **ONLY** be allowed a provisional enrolment, and will be subject to close monitoring to ensure the attendance target is met AND maintained.

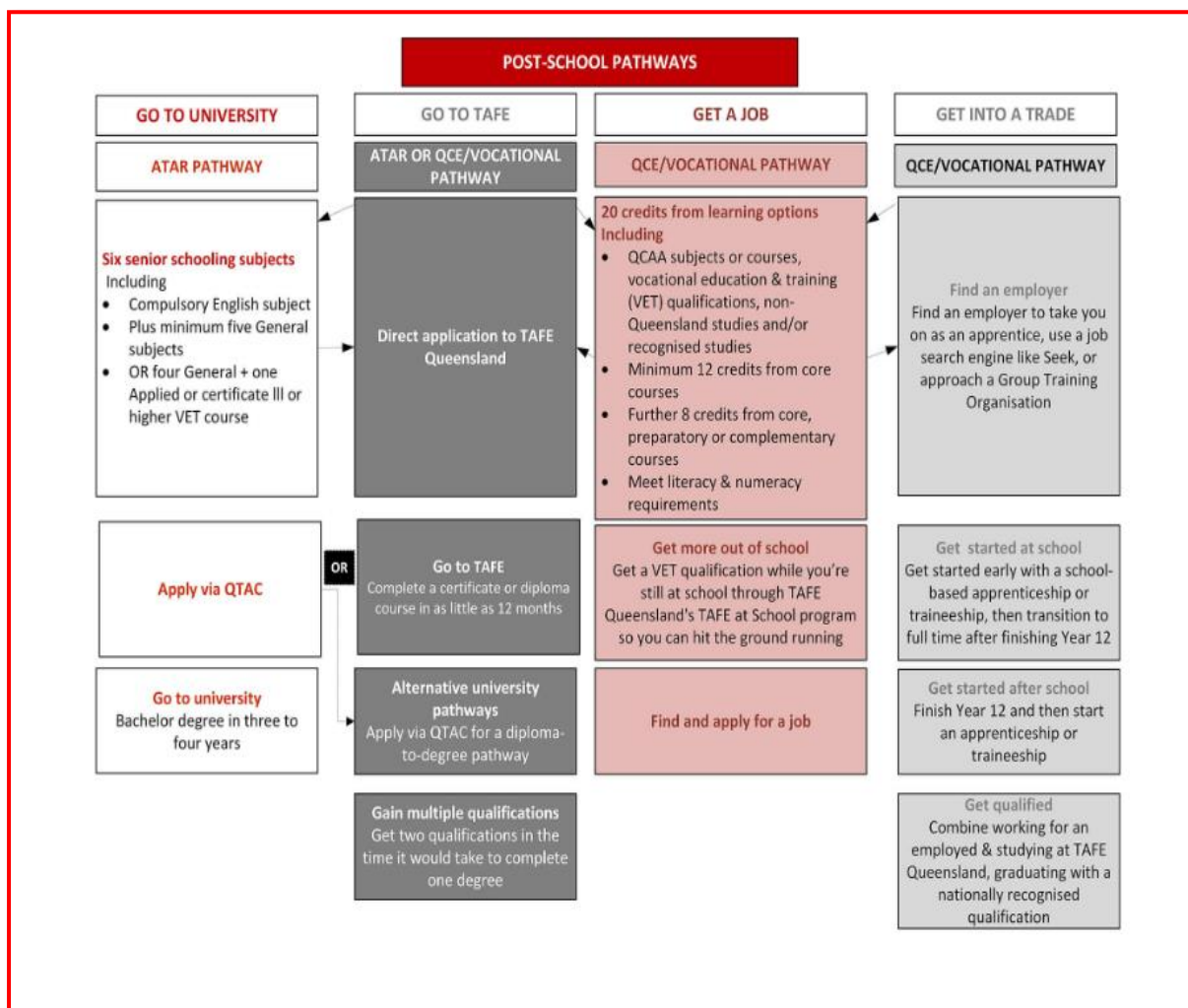

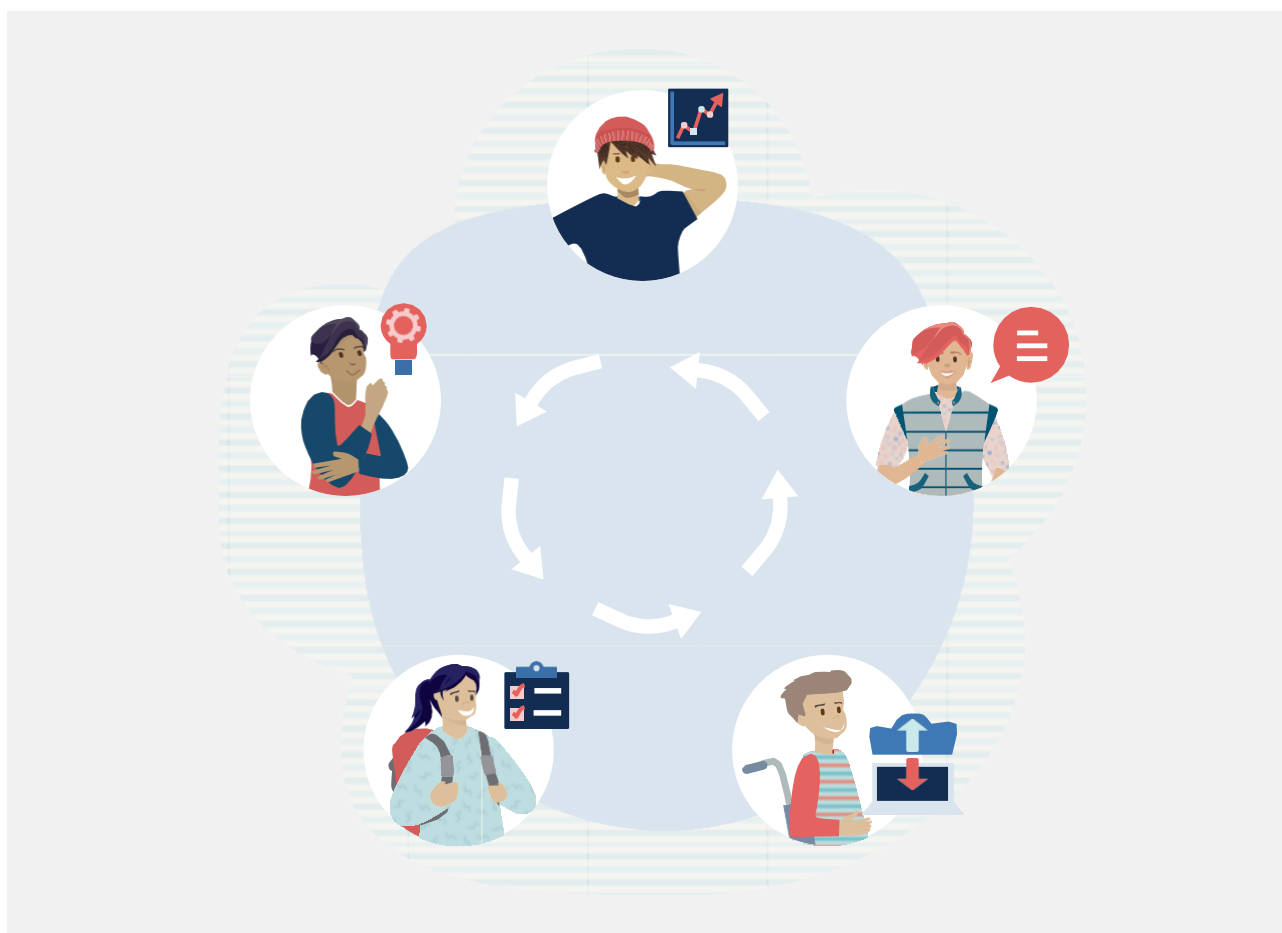

## All About Me

In the world of work, it is important to present our strengths with clarity and purpose so that we can maintain positive wellbeing and develop productive relationships with others. Your self-concept is unique to you and is made up of positive and negative elements. It relates to emotional (how you feel), intellectual (academic ability) and functional (practical ability) aspects and changes with age, time and context (you can act and feel differently depending on the situation). The key takeaway is that self-concept influences your life. Reflect on your academic and co-curricular performance and identify the employability skills below that you think you are using now or want to improve.



### *Employability Skills*

The following employability skills are useful to consider as you gain career insights and plan for your future. There are many employability skills and these examples are aimed to generate your thinking.

### What are employability skills?

While employers look for people with certain specialist skills and qualifications, they also look for other skills and qualities that will contribute to a positive and productive work environment. These are called employability skills (sometimes known as enterprise, transferrable, portable, generic or soft skills) and are essential for most jobs or careers. These skills can be adapted to meet the demands of diverse roles and situations.

### Why are employability skills important?

In the every-changing world of work, the importance of employability skills continues to grow. Even though specialist skills are necessary for many occupations, employers also place value on human-centered qualities like creativity, initiative, collaboration and social interactions.

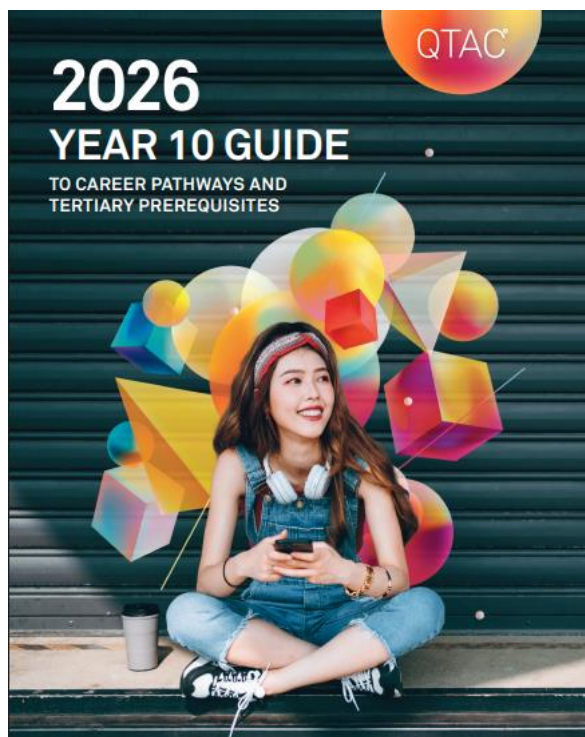

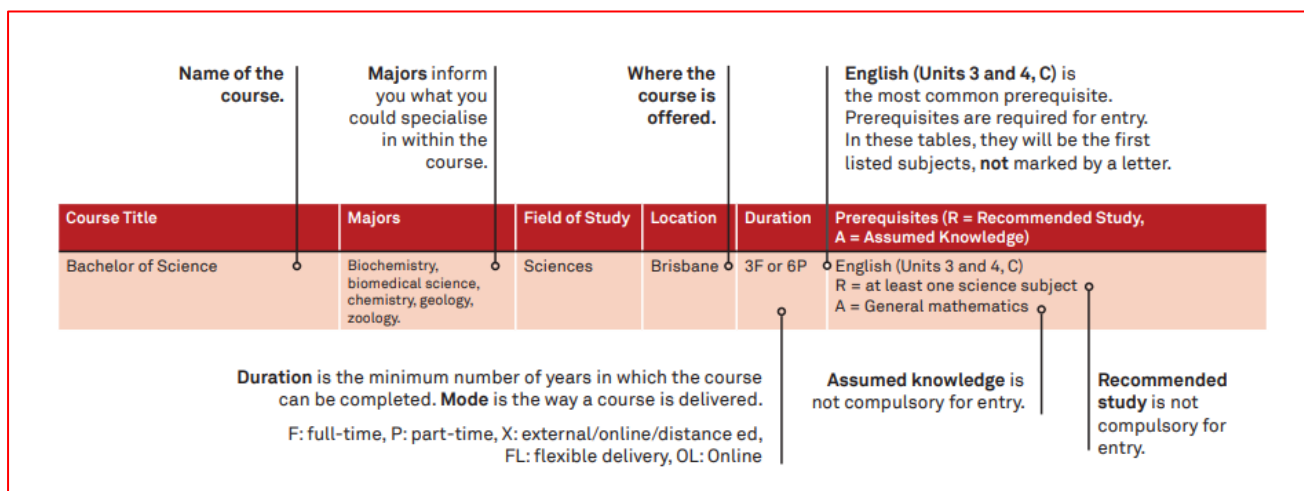

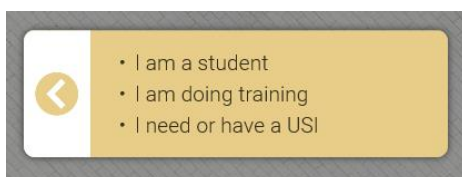
## How to Create a USI (Unique Student Identifier)
